#### Palliative and EOL Commission and NHS 10 year plan

The APM has a seat on the Palliative and EOL Care independent Commission, launched on the 11<sup>th</sup> December. There will be a call for written evidence in January, panel sessions with invited witnesses, roundtable events and a provider visit. We will keep you updated about how you can respond and of course the APM will be providing a response. Wes Streeting has been receptive to the commission and is expecting to have the findings in time to feed into the NHS 10 year plan. There will be more opportunities to engage with the government about the 10 year plan and we will share these with you as they are published.

#### **NCEPOD**

The NCEPOD EOL report was published late last year. It is a really important and influential report which recognises that palliative care needs to be involved earlier in the patient journey. ## **Committee Update**



#### **Race Equity Committee Update**

The REC has been growing over the past year. Our new Chair is Professor Dr Qamar Abbas, and Vice Chair is Dr Bhajneek Grewal. We have welcomed Dr Sunitha Daniel and Dr Amaal Weli to the committee. Dr Jamilla Hussain, our outgoing chair, also remains a valued member of the REC and we thank her for all her hard work in getting us this far.

We have successfully run Race Equity ECHO sessions on topics such as *Power differential & privilege, Racism and its manifestations in end of life care* and *Epistemic Injustice in the Workplace*. The ECHO network is a great way for racialised staff to connect and gain peer support. The REC has also worked alongside the Compassionate Communities team to deliver education sessions.

We have had some great conversations with the APM's recently appointed Lay Trustee, Trudie Roiz de Sa and will continue to work with her and the wider board on matters of race equity. In 2025 we will also be working more closely with our colleagues in the APM's EDI and Education committees.

#### **SAS and Hospice Doctors Committee Update**

The SAS and Hospice Doctors committee have welcomed two new members to the committee over the last 6 months or so, Dr Rebecca (Bex) Maiti and Dr Beth Goundry.

#### **Committee Work**

The committee have continued to support SAS and Hospice doctors by responding to both email and phone queries, mostly relating to CESR applications and contract issues. Beth Goundry has now taken responsibility for being point of contact for these enquiries.

We held a virtual study afternoon on 21 November with sessions on innovative SC drugs, endocrinology and career updates / contractual changes affecting SAS and hospice doctors. The study afternoon was well attended with our record numbers yet! The committee will continue to arrange 1 study session per year working alongside the Education committee on the topic. The study session will be targeted to all APM members, rather than just SAS and hospice doctors. Equally, to ensure we still meet the specific needs of SAS and Hospice doctors, we also plan to host a virtual event at least twice a year where the committee provide an online surgery for members. We are aiming for this to be a free session for members.

Alongside the work above, we have updated our Terms of Reference, and our aims and objectives. We have also spent time working on Development framework for SAS doctors to take account of Specialist Grade, to include sample Job Description and person specification.

#### **Neuro SIF Update**

2024 has seen the routine work of the NeuroSIF continue, distributing information and the occasional requests for support. Beyond this, we supported the APM endorsement of a chapter on neuropalliative care for a book on the care and rehabilitation of people living in care homes by Dr Emma Husbands and the development of a questionnaire on prolonged disorders of consciousness aimed, among others, at palliative care physicians.

In July, Idris Baker and I were invited to support Hospice UK on a project aimed at encouraging hospices to develop their work with patients with neurological conditions, which we hear has proved popular. In addition, two guideline development groups have recently been convened both of which will be seeking APM endorsement: one on palliative care guidelines in CJD and other prion conditions and another on an aspect of myasthenia gravis care. These are both in their early phases but look exciting.

Next year we hope to run the postponed neuropalliative care study day. A number of APM members have agreed to support the development of this and I will be in touch with those individuals in due course.

Finally, we would welcome a trainee to join the NeuroSIF committee. If you are interested, please discuss with your educational supervisor and then get in touch with me.
